Access to the NOAA Western Regional Center Identification Requirements

The Real ID Act of 2005 (P.L. 109-13) will become effective on January 19, 2015. This legislation established new compliance standards for State issued driver's licenses and identification cards. Upon full implementation of this Act, non-compliant State issued drivers and identification cards may not be used to enter NOAA facilities requiring presentation of identification cards.

When fully implemented, the following forms of identification will be acceptable for entry to NOAA facilities requiring presentation of identification cards:

- Enhanced Driver's License from the states of Washington, Minnesota, and New York
- U.S. Passport
- U.S. Passport Card
- U.S. Department of Defense CAC
- U.S. Federal agency HSPD-12 compliant ID cards
- U.S. Veterans ID
- U.S. Military Dependent's ID Card
- U.S. Trusted Traveler Card – Global Entry, SENTRI, or NEXUS
- U.S. Transportation Workers Identification Credential (TWIC)
- State issued Real ID Compliant Driver's Licenses and Identification Cards

Individuals wishing to have continued access to the NOAA Western Regional Center should ensure they have one of the above listed acceptable forms of personal identification.

IN THE NEAR FUTURE NON-COMPLIANT STATE ISSUED DRIVER'S LICENSES AND IDENTIFICATION CARDS MAY NOT BE USED FOR ACCESS TO THE NOAA WESTERN REGIONAL CENTER. These include non-enhanced state issued Driver's Licenses and identification cards from the following states and territories:
